03**ROLE**

Duties, salary, work location and business necessity that fit both sides.

THE QUESTION WE ANSWER

Do the applicant, employer and proposed role form a coherent case that is worth advancing now?

The answer may be suitable, conditional, information-insufficient, not currently recommended or appropriate for referral.

EMPLOYER-SIDE REVIEW

Can the business support the proposed hire?

Substantive operations are assessed through connected evidence - not one document alone.
